#### **1.** Curriculum Enrichment

- To follow an academic calendar for right planning and implementation activities on time to time for the college which is created by the academic council.

Every exam should be administered in accordance with the academic calendar. Regular tutorials are held to check on the students' progress. Low achievers are to be given remedial/special/classes/deprived instruction.
- Offer add-on courses to the students to impart new skills among them and to open the doors of opportunities.

Replace incandescent bulbs and tube lights and replace them with energy efficient light bulbs and tubes which consume very less electrical power thereby helping in keeping energy efficient campus. Continuously track and monitor energy usage in the campus by conduction of energy audit and implement ways to increase energy efficiency wherever possible.
