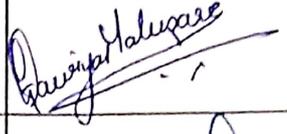

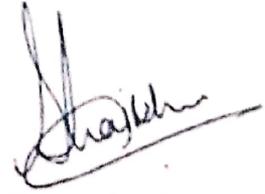

8. Any Other Matter:

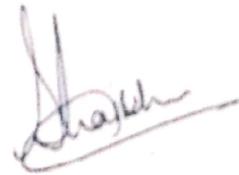

8. Any Other Matter:

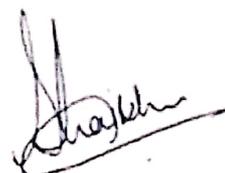
- Suggestions were made to initiate a green campus drive by planting trees.

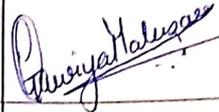

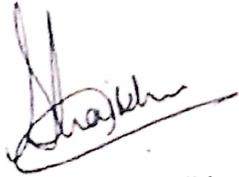

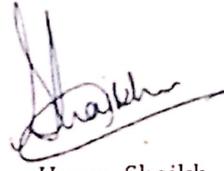
